- 2. Payment: Payment will be made within 30 (Thirty) days from bill receipt and payment will be made as per the following manner:
 - a. 90% of the unit price (Applicable only for WO value over 02 Lakhs at a time) will be paid after satisfactory installation of the equipment & subsequent certification of IT division/concerned users. Remaining 10% of the unit price (Applicable only for WO value over 02 Lakhs at a time) will be paid after 06 (Six) months satisfactory operation of the equipment. However, 100% payment may be paid in case of submission of Bank Guaranty amounting to 10% of the total work order amount for a period of 06 months.
 - b. The quoted amount must be included VAT but excluded from any kind of TAX. Bank will deduct VAT & AIT as per govt. rules.



- 3. Warranty: 03 Years full Warranty with Support & Spare Parts. During this period, the vendor shall repair any kind of defects including replacement of any parts at his own cost or replace the equipment, if necessary.
- 4. Support Level: The Supplier shall provide immediate response either by phone, e-mail or in person to any of the Purchaser's queries related to support and service.
- 5. Validity of the Rate: The quoted rate and other terms and conditions should cover for at least a period of 06(Six) months from the submission date of RFQ.
