Basic Requirement:

- a) The indenting Bidders have to apply in their letterhead pad. They should fulfill the following minimum qualifications and requirements:
- b) At least 03(years) years relevant experience in this line of business.
- c) Have executed work order of minimum Tk.30 (Thirty) Lac in a single transaction with any financial institution/reputed institution of the country.
- d) Interested bidders must have relevant experience in this line of business & they must have the infrastructure of Plastic card personalization bureau center with efficient technical team to execute the work within the stipulated time.
- e) Must Have updated/valid VAT, BIN and TIN Certificate.
- f) Following papers/documents must be enclosed with the tender:
 - i) Valid Trade License
 - ii) Bank solvency certificate
 - iii) Client list and contact person with performance (minimum 03) certificate (If available)
 - iv) Experience certificate of similar job-at least three company (If available)
 - v) Photocopy of Original Money Receipt provided by Prime Bank to the bidder for purchase of the tender document:

TENDER PREPARATION:

- Tender Schedule will be available from the Office of the undersigned on payment of Tk.2,500.00 (Taka Two Thousand Five Hundred) only for each schedule in the form of Payment Order/Bank Guarantee (non-refundable) favoring Prime Bank Limited issued by any Scheduled Bank during office hours (10:00 am to 03.30 pm) on any working day as per mentioned schedule.
- Tenders must be submitted in two-envelope system i.e, one Technical Proposal & one Financial Proposal
 mentioning Technical/Financial Proposal on the top of each envelope. These two proposals will be submitted
 together in a third envelope. All the envelopes should be sealed & signed.
- Technical proposal will be opened on the dated specified in the Tender Notice. Date of opening of the financial proposal will be communicated later on.
- The bid forms must be filled in through computer printer or in typing without overwriting and without any erasing and modifications and when completed shall contain all the required information.
- The Offer should be submitted in a sealed cover.

- The Offer shall be marked as "Procurement of NFC (Contactless) debit cards (MasterCard) & Card Personalization Outsourcing"
- Offers in the bid should be free of any condition and any conditional offer will disqualify the bidder. Unless
 otherwise provided herein bids shall be submitted on a firm and final price basis including all charges. Each page
 of the offer must be signed and sealed properly by authorized person of the bidder.
- · The Evaluation to be done by the Bank shall be final.

EARNEST MONEY:

The Bidders shall have to submit Earnest Money equivalent to 2.5% of the quoted value in the form of 'Payment Order'/BG in favor of Prime Bank Limited without which tender shall be rejected outright. The pay order/bank guarantee will have to be put in the financial offer. Validity of the pay order/bank guarantee should not be less than one year.

- (i) Earnest Money of unsuccessful bidder will be returned without any interest within 15 (Fifteen) days of award of contract to the successful bidder.
- (ii) Earnest Money of successful bidder will be returned after completion of the work to the full satisfaction of the Bank. (iii) Earnest money may be forfeited:
 - (a) If the bidder withdraws from the Tender process after submission of Tender.
- (b) If the successful bidder(s) refuses to undertake the work or fails to complete the work within the time specified in the work-order/Notification of Award.
