- Interested bidders may collect tender document for the said work on submission of a request letter addressing the undersigned as well as documentary evidence of the followings:
 - Practical work experience of minimum 05 (Five) years in interior decoration and furniture work of Bank's Branch and/or Head Office, Commercial Space for Multinational Companies. Copy of oldest Trade License need to be provided as proof.
 - Practical work experience to execute such type of work for minimum amount of Taka 1.00 Crore or above in a single work order.
 - Should have valid Registration, Ownership Document, VAT & TIN Certificate, up to date Trade License.
 - Following Technical Personnel of the firm must have IAB (Institute of Architects Bangladesh)/IEB (Institute of Engineers Bangladesh) membership number:
 - Project Manager: Having working experience for a minimum period of 05 years in relevant field (with Bachelor of Architecture or Bachelor of Science in Civil Engineering).
 - Project Architect: Having working experience for a minimum period of 03 years in relevant field (with Bachelor of Architecture).
