

Eligibility and other Conditions:

- Interested bidders are invited to pay physical visit at the premise and may collect tender schedule/ document for the said work from above mentioned address.
- If any bidder/ associate of bidder is found creating disturbance during submission of tender documents or obstructing smooth function to tender process or found misbehaving with any bidder/official, then authority may take legal action or forfeit deposited earnest money or take both action.
- Each tender must be submitted in separate sealed envelope mentioning the **Name of Tender on top of the envelope** to the address as mentioned above.
- Bidder needs to submit **Valid & Updated Trade License, TIN Certificate** as mandatory along with their bid otherwise tender will not be accepted.
- 10% Earnest Money** in form of Pay Order in favor of Prime Bank Limited needs to be submitted along with the group wise Price Offers as mentioned in schedule, which will be refunded to individual bidder after completion of entire tender process.
- Tender opening will be done at Prime Tower in presence of Auction Committee at any suitable time and day.
- Bidders will selected considering submitted group wise offers.
