Each tender must be submitted in sealed envelope mentioning the name of work on top of the envelop within 3.00 pm on the above mentioned submission date. The Technical Proposals may be opened at 3.30 pm on the same date (tender submission date) by the Bank's Tender Committee or at a convenient time of the Tender Committee.
