- 2. **Pre-bid meeting**: Interested bidders must attend a pre-bid meeting which will be held **at 11:30 p.m**. on **20 October 2024** through Zoom platform/Physical.
- 3. **Undertaken**: All selected service providers shall have to furnish an undertaking ensuring safe and timely Rent-a-car service.
- 4. Financial Proposal: Submit as per Annexure -1
- 5. **Payment:** Payment will be made within 30 (thirty) days after receiving invoice/ bill from the Service Provider as desired Bank.
  - a. Payment will be made after receiving invoice.
  - b. Payment will be made after deducting of VAT & AIT as per Government rules.
