- Provide valid Trade License/Incorporation Certificate/Ownership Document, BIN, TIN Certificate & Bank Solvency Certificate.
- The Following Technical Personnel of the firm should meet below criteria:
 - Civil Engineer (Permanent/Contractual) :** Having working experience for a minimum period of 05 years in relevant field (Bachelor of Science/Diploma). Please submit proof of documents.
 - Electrical Engineer (Permanent/Contractual) :** Having working experience for a minimum period of 05 years in relevant field (Bachelor of Science/Diploma). Please submit proof of documents.
- Vendor with previous bad record with Prime Bank PLC. will be directly disqualified. Their financial offer will not be acceptable and will not be opened.

4. **Tender Sale Time :** No Tender Document will be sold after the last date of sale as mentioned above.



5. **Pre-Bid Meeting** : The interested bidders shall have to attend a **pre-bid meeting** (Physical Meeting) at **Prime Tower (10th Floor), Plot # 08 & 35, Nikunja-2, Khilkhet C/A, Airport Road, Dhaka-1229** (meeting time & date mentioned as above).
6. **Earnest Money** : Earnest Money (refundable to the unsuccessful bidder) equivalent to (Earnest money % mentioned in above table) the quoted amount in the form of Payment Order/Bank Guaranty in favor of Prime Bank PLC. issued by any Schedule Bank shall have to be submitted along with the Tender Document, failing which shall cause rejection of the Tender Document.
7. **Tender Submission** : Each tender must be submitted in sealed envelope mentioning the name of work on top of the envelope to the office of the undersigned as per aforesaid date **within 3:00 pm**. Submission of Tender after the specified time shall not be acceptable.

The name, address and telephone number of the contact person should be mentioned in the forwarding letter both of the **"Technical Offer"** and the **"Financial Offer"**.
