Eligibility and other conditions:

A. Basic Requirement

The indenting Bidders have to apply in their letterhead pad. They should fulfill the following minimum qualifications and requirements:

- a. The Tenderer should preferably be a manufacturer / Local Agent / Dealer / Distributor / Supplier of internationality reputed institute/brand(s).
- b. At least 03 (three) years relevant experience in this line of business.
- c. Have executed work order of minimum Tk.50 (Fifty) Lac in a single transaction with any financial institution/reputed institution of the country.
- d. Must have updated/valid VAT, BIN and TIN Certificate.
- e. Following papers/documents must be enclosed with the tender:
 - i. Valid Trade License
 - ii. VAT registration certificate
 - iii. Bank solvency certificate
 - iv. Client list and contact person with performance (minimum 03) certificate (If available)
 - v. Experience certificate of similar job-at least three company (If available)
 - vi. Photocopy of Original Money Receipt provided by Prime Bank to the bidder for purchase of the tender document:

B. TENDER PREPARATION:

- Tender Document will be available from the Office of the undersigned on payment of **TK4,000** (Taka Four Thousand) only for each schedule in the form of Payment Order (non-refundable) favoring Prime Bank PLC. issued by any Scheduled Bank during office hours (10:00 am to 04:00 pm) on any working day as per mentioned schedule.
- Tenders must be submitted in two-envelope system i.e., one Technical Proposal & one Financial Proposal mentioning Technical/Financial Proposal on the top of each envelope. These two proposals will be submitted together in a third envelope. All the envelopes should be sealed & signed.
- Technical proposal will be opened on the dated specified in the Tender Notice. Date of opening of the financial proposal will be communicated later on.
- The bid forms must be filled in through computer printer or in typing without overwriting and without any
 erasing and modifications and when completed shall contain all the required information.
- The Offer should be submitted in a sealed cover. The Offer shall be marked as "Supply of Mini Payment Cards- Sticker Payment Cards"

- Offers in the bid should be free of any condition and any conditional offer will disqualify the bidder. Unless otherwise provided herein bids shall be submitted on a firm and final price basis including all charges. Each page of the offer must be signed and sealed properly by authorized person of the bidder.
- The Evaluation to be done by the Bank shall be final.

C. EARNEST MONEY:

The Bidders shall have to submit Earnest Money equivalent to 2% of the quoted value in the form of 'Payment Order/Bank Guarantee' in favor of Prime Bank PLC. without which tender shall be rejected outright.

- (i) Earnest Money of unsuccessful bidder will be returned without any interest within 15 (Fifteen) days of award of contract to the successful bidder.
- (ii) Earnest Money of successful bidder will be returned after completion of the work to the full satisfaction of the Bank.
- (iii) Earnest money may be forfeited:
- (a) If the bidder withdraws from the Tender process after submission of Tender.
- (b) If the successful bidder(s) refuses to undertake the work or fails to complete the work within the time specified in the work-order/Notification of Award.
