5. Warranty: Standard Warranty of 02 years will be applicable. During this period, the vendor shall repair any kind of defects including replacement of any parts at their own cost.
6. Support Level: The Supplier shall provide immediate response either by phone, e-mail, and fax or by person to any of the Purchaser's queries related to support and service.
7. If the devices are not compatible with PBL Agent Banking system or Election Commission database for fingerprint verification, Bank shall not accept those devices and return back to vendor.
8. After going through the terms & conditions, if you are interested to participate in the bidding process: Please submit your proposal in your company's letterhead pad as per above mentioned format duly signed by your company's authorized representative in the **tender box kept at FMD, on or before 08.11.2021 by 2:30 p.m. and clearly marked "Offer for fingerprint scanner devices for Agent Banking"** on the top of the envelope. No quotations shall be dropped before or after this time period.
