3. Payment: Payment will be made within 30 (Thirty) days from receipt of bill from the supplier. Payment will be made as per the following terms and conditions:

- A. 90% of the unit price will be paid after satisfactory installation of the equipment & subsequent certification of concerned division/concerned users.
- B. Remaining 10% of total price will be paid to the supplier after 06 (Six) months of satisfactory operation of the equipment.
- C. Bank will deduct VAT & AIT as per govt. rules.

4. Warranty & After Sales Service:

- (i) The client requires 2 (Two) years full warranty from the date of installation. During this period, the selected contractor must repair any defect/replace any parts of the equipment and render services in connection thereto at its own cost.
- (ii) The contractor shall also provide after sales service of the supplied equipment at free of cost as when asked by the client for 02 (two) years including 3 (three) times periodic service & maintenance/year.
- (iii) The response time shall be 2(Two) hours and trouble must be resolved/rectified within 6-12 hours.
