Scope of Work

The key functional requirements for the new website are outlined as follows:

- 3. Google Map enabled ATM & Branch locator
- 4. Search Engine Optimization
- 5. Integrate with analytics software like Google analytics
- Website and page analytics
- 7. Lead generation page
- 8. Loan calculator
- Real time Exchange Rate
- 10. PDF version of Loan/ Account Application Form which can be filled directly by the customer
- Incorporate more dynamic backend site administration capabilities, including the ability to receive automatic email notifications for Department and Site Administrators, (i.e. to ensure the prompt release of approved information)

- 18. Meeting all kind of requirements set by the Central Bank of Bangladesh
- 19. Website should have both English & Bangla version
- 20. High ease of content administration i.e. ability to add and manipulate text directly on the website, to facilitate better font selection - larger, cleaner fonts and differing sizes for emphasis on key items
- 21. Document converter that allows documents to be downloaded in various formats: pdf, word,
- 22. Inclusion of a significant 'archive' section that includes annual reports and publications
- 23. Inclusion of a 'search' bar to enable easier access to information by users
- 24. Separate page for every division and must have separate campaign page facility

Experience
